

MOTION TO CLOSE THE OFFICE OF THE CLERK OF FIRST CITY COURT

ON THE MOTION OF Austin J. Badon, Jr Clerk of First City Court for the Parish of Orleans, State of Louisiana, appearing herein in proper person, and on suggesting to the Court, pursuant to the declaration of emergency due to the safety concerns of the Court regarding Public Health Crisis (COVID-19). 
